2. Personal Data We Collect

3. Legal Basis and Purposes of Processing

We process personal data for the following purposes and, where required by UAE PDPL, on the following legal bases:

4. Cookies and Similar Technologies

We use cookies and similar technologies to ensure that our website operates smoothly, to improve your browsing experience, and to provide insights that help us enhance our services.

4.1. What are cookies?

Cookies are small text files placed on your device when you browse a website. They allow us to remember your preferences, understand how you interact with the website, and tailor content or features to your needs.

4.2. How we use cookies?

4.3. Third-Party cookies:

- Some cookies are placed by third-party providers whose tools or services we integrate into our website.
- These may include analytics services, media players, or marketing networks.
- We do not control how these third parties use the data they collect; please refer to their respective privacy policies.

4.4. Managing Your Cookies Settings:

You have full control over your cookie preferences. You can:

- Adjust your settings directly through our cookie management panel;
- Restrict or block cookies via your browser settings;
- Delete cookies stored on your device at any time;

Please note that disabling some cookies may affect your ability to use certain features of the website.

5. How We Share Personal Data

We do not sell your personal data. We may share personal data only with the following categories of recipients, and only to the extent necessary for the purposes described above:

5.1. Service Providers:

- Third-party vendors providing services such as website hosting, IT support, security, analytics or email services, who are bound by contractual confidentiality and data protection obligations.

5.2. Group Companies / Affiliates:

- Coffeemania group entities (for example in Russia or other jurisdictions) for internal administrative purposes, consistent branding and coordination of hospitality services, where permitted by law and subject to appropriate safeguards.

5.3. Professional Advisors and Auditors:

- Lawyers, auditors, consultants and similar professionals, to the extent necessary for the provision of their services and in connection with legal or compliance matters.

5.4. Public Authorities and Law Enforcement:

- Where required by applicable law, regulation, court order or law enforcement request, or where disclosure is necessary to protect our rights, safety of our guests or the public.

If we transfer personal data outside the UAE, we will do so in compliance with applicable cross-border transfer requirements under the UAE PDPL, including ensuring an adequate level of protection or appropriate safeguards where required.

6. Data Retention

We retain personal data only for as long as necessary to fulfil the purposes for which it was collected, including for the purposes of satisfying any legal, accounting or reporting requirements.

In particular:

- Contact and communication retained for the duration necessary to respond to your inquiry and for a reasonable period thereafter for record-keeping and dispute resolution, unless longer retention is required by law.
- Technical and analytics retained for a limited period necessary for security, performance monitoring and statistical purposes, typically in aggregated or anonymized form.

When personal data is no longer required, we will delete or anonymize it in accordance with our data retention policies and applicable law.

7. Your Rights

Subject to the conditions and exceptions set out in the UAE PDPL, you may have the following rights in relation to your personal:

To exercise any of these rights, please contact us at gcc@coffeemania.com. We may need to verify your identity before responding to your request. We will process your request in accordance with applicable UAE law and within the timeframes prescribed by the UAE PDPL.

If you believe that our processing of your personal data infringes applicable law, you may also have the right to lodge a complaint with the competent UAE supervisory authority, without prejudice to any other administrative or judicial remedies available to you.

8. Data Security

We implement appropriate technical and organizational measures designed to protect personal data against unauthorized access, loss, misuse, alteration or disclosure.

Measures may include, as appropriate:

- Use of secure servers and restricted access based on role.
- Protection of our IT systems against malware and unauthorized access.
- Internal policies and staff training regarding confidentiality and data protection.

However, no method of transmission over the Internet or method of electronic storage is completely secure, and we cannot guarantee absolute security.

9. Third-Party Websites

This Website may contain links to third-party websites, social media platforms, booking engines or other services that are not operated by us.

We are not responsible for the privacy practices or content of such third-party sites. If you follow a link to any third-party website, you should review its own privacy policy before providing any personal data.

10. Children's Privacy

Our Website and services are not intended for children under the age of 18, and we do not knowingly collect personal data from children under 18 via the Website.
